7. REPORTS / DISCUSSION

A. Approval of the Fiscal Year 2018/2019 Operating Budget

Princess Hester, RCHCA Administrative Services Officer, reported that the Operating Budget consists of the General Fund, Contracts, and the Lake Mathews Reserve Endowment. RCHCA employees five full-time staff and anticipates creating one additional position to assist with consulting and contractual obligations.

The General Fund is anticipated to bring in revenues of \$900k, and anticipated expenditures are \$510,352, which leaves a balanced budget with excess revenues of \$400k.

The Lake Mathews Reserve Endowment is anticipated to fund draws at \$570k, and the expenditures would match that amount.

Overall, the budget consists of an approximate 14% increase in revenue. Any additional savings realized will reduce the draw down amount from the lake Mathews Reserve Endowment.

B. Status Update on the Stephens' Kangaroo Rat Recovery Efforts

Princess Hester, RCHCA Administrative Services Officer, reported that staff continues to work with the U.S. Fish and Wildlife Services (USFWS) to demonstrate Stephens' Kangaroo Rat (SKR) recovery. In March 2018, Vice-Chair Manos and Board member Maryann Edwards accommodated staff in an advocacy visit to Sacramento to meet with Legislators and USFWS.

Staff urged USFWS to finalized the 1997 draft Recovery Plan to ensure no additional requirements are added to the Plan. As it turns out, the Plan does not need to be finalized.

In partnership with USFWS, many steps have been completed toward the recovery of SKR. Remaining tasks include a Range-Wide Monitoring Protocol in coordination with San Diego County, as SKR's geographical range extends into northern San Diego. Additional tasks include a genetics study, a 5-factor analysis, and a proposed rule for down listing, to be completed by USFWS. An overall management strategy to continue managing SKR and its habitat will be developed.

The next step would then be to petition USFWS to support the coordinating efforts in order to work on the delisting of SKR in San Diego County.

Staff is working on a proposal to request USFWS fund the efforts to support the Range-Wide Monitoring Protocol.

C. Report on Educational Outreach Programs

Princess Hester, RCHCA Administrative Services Officer, reported that events are held at the reserves to celebrate Endangered Species Day, and celebrate endangered species. This year, over 700 students from schools throughout Western Riverside County participated in an art contest.

The theme was "Where our World and the Natural World Meet." Awards are presented to the winners of various categories. Included in the Board members stipend folders were various drawings by some of the participating students.

D. Report on the Stephens' Kangaroo Rat Reserve Management and Monitoring Efforts

Brian Shomo, RCHCA Natural Resources Manager, introduced a new employee, Scott Curry, Open Space Habitat Technician, who will assist with crew management and other tasks.

RCHCA applied for and received funding through the State Responsibility Area Grant for fire fuel / habitat management in the amount of \$142,000. An additional 2,200 man hours were awarded, approximately \$45,000, for continued fuel management.

Two and a half miles of fuel breaks were installed; 80 acres of dead citrus trees were removed; and all tamarisk and tobacco trees were removed.

A Cal Fire prescribed fire is planned for May 24, 2018, at the Lake Mathews Reserve. The Bureau of Land Management recently hosted a Federal Fire Investigators Class. Student investigators focused on learning fire behavior, origin, methods of ignition, and cause of spread.

Staff has created a GPS tool to track and record patrol efforts in real time, which allows tracking of locations staff have traveled.

In addition to monitoring the Stephens' Kangaroo Rat, there are 65 species that RCHCA is contracted to monitor, one of which are bats. Staff obtained an acoustic recorder which can determine the type of bat(s) in the area. It turns out there are more species of bats at the Lake Mathews Reserve than initially known.

E. Potential Full Consolidation of RCHCA Staff and Operations with WRCOG

Rick Bishop, RCHCA General Manager, reported that WRCOG has been acting as the administrator of RCHCA for the last few years. Significant savings have been achieved, and the Agency has been able to embark upon delisting the Stephens' Kangaroo Rat and provide public access to some of the RCHCA lands.

One kink in the process is that RCHCA staff still remain County employees. RCHCA staff operate under different personnel policies and procedures, as well as a different holiday calendar. Mr. Bishop has met with County staff, who have no objection to the full consolidation of RCHCA into WRCOG. WRCOG's Executive Committee recently received this item at its meeting earlier this month, and also have no objections.

With a full consolidation, RCHCA will continue to operate under its own Joint Powers Agreement, and this Board will continue to meet as it currently does.

RCHCA staff have expressed no objections to becoming WRCOG employees. RCHCA will continue to retain County Counsel for its legal oversight.

Member agencies impose a mitigation fee on certain types of development within their jurisdictions for the Stephens' Kangaroo Rat. All mitigation fees collected for the Stephens' Kangaroo Rat are forwarded to RCHCA for the period of April 1 through June 30, before July 31; for the period of July 1 through September 30, before October 31; for the period of October 1 through December 31, before January 31; and for the period January 1 through March 31, before April 30 of each fiscal year.

The attachment shows the status of fee collections for Fiscal Year 2017/2018 as of June 30, 2018.

The purpose of this item is to provide an update on staff activities representing the RCHCA on the Reserve Managers' Coordinating Committee (RMCC).

Requested Action:

The RMCC is a collaborative forum for Stephens' Kangaroo Rat (SKR) reserve and land managers in which members share biological and management issues, discuss monitoring methodology, and consider potential habitat restoration and enhancement opportunities. The RMCC provides a valuable opportunity for the sharing of successes and stimulating brainstorming, and generally meets quarterly.

Reserve Managers Coordinating Committee Meeting

1. Managers are still facing the Stinknet invasion and the plant is being found throughout the County. RCHCA is working on an agreement with the University of California, Riverside, to conduct research to eradicate the species on reserve lands. The goal is to identify, using drone technology, and treat before flowering and seed dispersal. The Southern California Regional Project is working to identify funding for restoration after invasive species removal.
2. Managers discussed general suggestions for a regional SKR monitoring plan that would assist the regulatory agencies in the on-going efforts to recover SKR. The conversation focused on the different thresholds of monitoring required by various agencies which would make any standardized monitoring plan difficult. Various monitoring plans are currently being implemented based on management plans and Habitat Conservation Plans requirements including presence / absence, occupation (presence), density, etc.
3. Managers discussed potentially drafting an MOU for regional management of SKR habitat. Currently there are no management actions required by the various land managers. The MOU would state performance goals for SKR habitat management based on potentially occupied acreage. The Managers expressed that a cooperative agreement or letter of support stating that they would support SKR management, but performance thresholds would be difficult to get approval by their legal counsels or regional directors.

The purpose of this item is to provide an update on the status of the management services arrangement for the RCHCA and Western Riverside Council of Governments (WRCOG).

Requested Action:

1. Receive and file.

In December 2015, the RCHCA Board of Directors and WRCOG Executive Committee approved a five-year Agreement between WRCOG and RCHCA that transferred the duties of administration and management of RCHCA activities to WRCOG. Under the Agreement, WRCOG’s Executive Director serves as the General Manager / Executive Director of RCHCA and is responsible for general duties include administering, coordinating, and supervising the activities of RCHCA as set forth in RCHCA’s Joint Powers Agreement (JPA).

With the current arrangement, RCHCA staff remain as County employees under an Agreement with the County of Riverside for Human Resource services. This arrangement allowed time for the transfer to be evaluated and to ensure that the management services consolidation was efficient and successful. It also provided time for RCHCA staff to become familiar with WRCOG’s organizational and operational practices.

At its May 2018 meeting the RCHCA Board of Directors directed staff to work with Riverside County and WRCOG to fully consolidate RCHCA staff and operations into WRCOG. The Board also approved the 12th Amended and Restated Joint Powers Agreement revising the language relating to the RCHCA’s auditor. The amendment was necessary because the language in the previous version of the JPA named the County of Riverside’s Auditor Controller financial administrator for the RCHCA.

The 12th amendment now states, pursuant to Government Code Section 6505.5, that the auditor of the RCHCA shall be a certified public accountant appointed by the RCHCA Board of Directors. The Amendment also restated the authority of the General Manager.

As of this writing, 10 of the 11 jurisdictions have approved the JPA. Once the JPA has been approved by all member agencies RCHCA County staff will transition into WRCOG.

Prior Actions:

May 17, 2018: The RCHCA Board of Directors directed staff to work with Riverside County and WRCOG to fully consolidate RCHCA staff and operations into WRCOG. The Board also

approved the 12th Amended and Restated Joint Powers Agreement and authorized staff to circulate and obtain signatures from the member agencies.

December 18, 2015: The RCHCA's Board of Directors and WRCOG's Executive Committee approved a five-year Agreement between WRCOG and RCHCA that transferred the duties of administration and management of RCHCA activities to WRCOG.

Fiscal Impact:

RCHCA is financially stable and operates under a separate budget. RCHCA compensates WRCOG for all costs related to administration of the Agency pursuant to the management services arrangement. Under a full consolidation, RCHCA will operate as a Program under WRCOG. The structure will not create any additional financial burden on WRCOG or the RCHCA. The RCHCA will continue to pay both its current budgeted expenditures, as well as future retirement costs such as pension and healthcare for RCHCA employees.

Subject: Examination of Potential Restoration and Financial Opportunities of Small Scale Solar Projects on RCHCA-Owned Surplus Lands

The purpose of this item is to request that the Board of Directors authorize staff to examine the feasibility of installing small scale solar projects on RCHCA-owned surplus lands for purposes of potential revenue generation and habitat restoration.

Requested Action:

1. Authorize staff to examine the feasibility of using small scale solar projects to generate revenues and restore degraded landscapes within RCHCA-owned surplus lands.
-

The RCHCA owns and manages lands in Western Riverside County outside of the Stephens' Kangaroo Rat (SKR) Habitat Reserve System. These surplus lands are currently not being utilized and could greatly benefit from restoration. These lands were originally intended to be sold or leased to provide additional funding for assembling the Reserve System; sales and/or leases have not occurred and thus these lands remain under RCHCA ownership.

Staff has identified eight candidate parcels of surplus lands potentially suitable for a small scale solar project that could restore degraded landscapes and allow these lands to benefit from a new source of renewable energy that will provide reduced energy costs to local jurisdictions while simultaneously providing funding to support SKR habitat management. These parcels are collectively 68.5 acres and are located outside the City of San Jacinto (Assessor Parcel Numbers 307-120-009 & 307-210-022). They are adjacent to the San Jacinto River and situated between existing agricultural fields with power distribution poles and lines already on site.

A similar project was completed at the Santa Margarita Ecological Reserve (SMER) outside the City of Temecula. The SMER is a research field station of San Diego State University and the San Diego State University Foundation. The SMER helps conserve land for the long-term preservation of the Santa Margarita watershed, similar to the RCHCA's mission of conserving habitat for the SKR.

The solar project has allowed the SMER to benefit from an agreement with the City of Temecula and Lake Elsinore purchase power from a solar power facility slated for land on the reserve. In this instance, a small (less than 15 acres) solar array replaced a former non-native eucalyptus grove and provided annual energy cost savings to the City of Temecula and Lake Elsinore, resulting in millions of dollars saved over the lifespan of the project for both municipalities. In addition, the SMER benefits by receiving \$35,000 annually for the management of the Reserve and research on the compatibility of renewable energy and habitats / watersheds. It should be noted that this project was installed without any major modifications to the land, minimal ground intrusion, and no impacts to cultural resources. The installation was completed in such a way that the panels are spaced farther apart, higher off the ground and follow the contours of the landscape thereby allowing native

vegetation to regrow increasing habitat / watershed value and potential movement and occupancy by native species. The annual funds provided to the SMER will support ongoing research on the long-term restoration for the land, compatibility and the short and long-term ecological benefit to using renewable energy as a mechanism for habitat conservation and restoration. At the end of the project, the panels and infrastructure will be removed and the land will be restored to its natural state providing additional savings to the SMER, estimated at \$800,000.

RCHCA staff believes that its surplus lands could possibly be used in a similar fashion. In addition to the potential revenue generating opportunities to the Agency, staff is interested in the potential use of a demonstration site to test certain restorative activities on the parcel to examine and monitor whether habitat can be restored in concert with, in this case, small scale solar uses.

If authorized, RCHCA staff will identify potential environmental and financial benefits, and further discuss other opportunities and constraints for the RCHCA, and seek further direction.
