Summary:

WRCOG is embarking on its eighth round of the WRCOG Fellowship Program, which introduces recent college graduates and college seniors to careers in the public sector. The program has created opportunities for 90 students over the past seven years to learn and grow into roles in finance, planning, IT, and administration. Today, staff will share information about the eighth round of the program.

Purpose / WRCOG 2022-2027 Strategic Plan Goal:

The Fellowship Program's purpose is aligned with the Strategic Plan Goals of:

- 1. Develop and implement programs that support resilience for our region.
- 2. Provide a safe, inclusive environment that values employees.

Discussion:

Background

WRCOG's Public Service Fellowship Program was established in 2016 and is a regular program administered by WRCOG. The goal of the Program is to retain locally trained students to fulfill the subregional need for a robust public sector workforce and to combat the problem of "brain drain", which occurs when local students graduate and then leave the region to seek full-time employment outside of the region.

The Fellowship Program aims to create a local public sector career pipeline for students through partnership with WRCOG member agencies. Since inception, 90 Fellows have been placed in member agencies seven rounds of the Program, contributing approximately 72,000 hours of service to Western Riverside County. Today, several Fellow alumni are employed throughout the subregion, while others have pursued alternative opportunities like graduate school.

WRCOG's Public Service Fellowship Program, initiated in 2016, creates opportunity for local students to

participate in public sector career fields, with 90 Fellows contributing 72,000 service hours to date. WRCOG oversees the program, while individual host agencies provide mentorship and supervision. Fellows work up to 960 hours, with hosting costs shared between WRCOG and member agencies. In the program's upcoming eighth round, ten Fellows will be placed amongst member agencies, benefiting from monthly career readiness sessions and insights into the public sector.

General Fellowship Logistics

In terms of logistics, WRCOG is responsible for general Program administration and oversight, while participating members, or host agencies, are responsible for day-to-day supervision and mentorship of an assigned Fellow. WRCOG also provides monthly training sessions for Fellows on career readiness and other relevant topics during Professional Development Sessions to support their hands-on work experience at a host agency. All Fellows are allotted to work up to 960-hours during their Program and can work up to 30 hours a week. Placement of Fellows in member agencies is prioritized on an every-other-year basis. Members who do have priority status, meaning they did not host a Fellow in the prior year's pay 50% of the cost of a Fellow, while members who do not have priority, those who did host a Fellow the previous year, pay 100% of the cost of a Fellow. For reference, the total cost of hosting a Fellow is \$20,000 so a 22 member with priority status would contribute \$10,000 to the cost of hosting a Fellow. The purpose for this priority system is to extend remaining Program funds. After review, of past programming, it was determined that WRCOG would sponsor 10 fellows through the program through WRCOG funding.

Round Seven Recap

Four Fellows were selected to participate in the seventh round of the Program, which took place in Fiscal Year 2022/23. Fellows were placed throughout nine agencies including the City of Eastvale, the County of Riverside and the Economic Development Agency. Over the course of nine months, Fellows participated in monthly professional development sessions, where they heard from a number of guest speakers on career readiness and the innerworkings of the public sector.

Fellowship Survey Results

WRCOG conducts regular surveys to assess the effectiveness of the program. Most participants convey a positive experience and continued interest in hosting a Fellow in the eighth round of the Program. For members who expressed concerns at any point in the Program or on survey responses, staff connects with the member to understand and learn how to provide more support and improve the overarching Program.

Round 8

In anticipation for the eighth cohort of the Program, staff is working to facilitate both host agency and Fellow applications. Additionally, in light of the pay rate concern expressed by Fellows, staff cross-examined other fellowship programs and concluded that WRCOG's Program was at a distinct competitive disadvantage due to a Fellows' pay rate. In response to this, staff reviewed the Program budget, WRCOG and host agency contributions, and the overarching cost of the Program to conclude that it is both feasible and in the Programs best interest for a Fellows' pay rate to be increased to \$20.00 an hour. Notably, this pay rate increase will not impact a host agency's financial contribution to the Program.

Financial Summary:

Fellowship-related activities are included under the Fellowship Program (4700) in the General Fund (110). The Fellowship was originally funded with carryover revenues from the PACE program and has not received additional funding since then, and there is approximately \$200k left to fund the program.

Summary:

This item is reserved for a presentation regarding regional broadband initiatives from Riverside County Information Technology.

Purpose / WRCOG 2022-2027 Strategic Plan Goal:

The purpose of this item is to present updates regarding the County of Riverside's efforts to improve broadband services within the County. This item is related to WRCOG's Strategic Plan Goal #5.1.3: (Support investment in projects, infrastructure, and programs in the region including Broadband/Smart Cities infrastructure).

Discussion:

Background

High-speed broadband internet is critical to our future. In addition to helping households connect to online resources in health, education, employment, and more, broadband internet acts as a catalyst for prosperity and economic growth in high-income economies. In recent years, Riverside County has made tremendous advances in bringing internet connectivity to homes, businesses and community institutions. But for many, access to reliable internet remains out of reach due to:

- · High monthly costs
- Limited or non-existent broadband infrastructure in certain regions
- Inadequate local, state, and federal policies
- Limited community stakeholder involvement

RivcoConnect is dedicated to addressing these challenges so that we can finally close Riverside County's digital divide. RivcoConnect is committed to building out Riverside County's high-speed internet infrastructure to employment, education, public safety, health care, entertainment, business, and governmental assistance. Established in 2016 by the Riverside County Board of Supervisors, this multi-

jurisdictional regional project brings together all 28 member cities and participating local tribes to achieve three goals:

- 1. Build out Riverside County's high-speed information and technology infrastructure.
- 2. Increase access to affordable and reliable internet for all households.
- 3. Spark economic growth, business development, and educational innovation.

Summary:

Member dues make up one of WRCOG's funds, and one of the Agency's budgeting principles is to focus on the long-term health of each fund. The funds produced by member dues is not sustainable, as they have not been adjusted since Fiscal Year (FY) 2009/2010 when they were reduced by 15%; this was brought forward by staff during the budget process for FY 2023/2024. Staff proposed to begin the member dues discussion and received direction from the Administration & Finance Committee to work with the Technical Advisory Committee (TAC) to explore options. A working group consisting of TAC members has formed to ensure thorough exploration, and that valuable input from members is provided.

Purpose / WRCOG 2022-2027 Strategic Plan Goal:

The purpose of this item is to provide an update on exploring options for WRCOG member dues. This effort aligns with WRCOG 2022-2027 Strategic Plan Goal #3 (Ensure fiscal solvency and stability of the Western Riverside Council of Governments).

Discussion:

Background

As was previously presented during the budget process for FY 2023/2024, WRCOG total member dues are currently set at \$294k. This is a fixed amount that has not changed since FY 2009/2010, when they were reduced by 15% due to the Great Recession. WRCOG has distributed its dues based on population and assessed value (which is described in the WRCOG Bylaws), similar to what other regional agencies do, such as the Coachella Valley Association of Governments and the Southern California Association of Governments, which calculate and distribute dues based off of population and Assessed Valuation. Others, such as the San Gabriel Valley Council of Governments, calculate its dues based off of its total general operating budget and assign a base fee plus a per capita amount.

WRCOG dues were originally calculated based off a weighted average of population and assessed value for cities and the county, while the water districts and the Riverside County Office of Education used fixed amounts. The weighted average allocation has not been updated, which provides an opportunity to

adjust the allocation among agencies and improve the fairness of the cost. The core figure to be allocated has not been adjusted since 2008. At that time, the amount was decreased in response to global economic conditions but, unlike other fees that were decreased at that time, the fee did not recover as conditions improved. Additionally, the Consumer Price Index has increased approximately 27% in that time and has caused WRCOG to rely more heavily on revenues from other programs to fund core functions.

The table below displays the current dues of each WRCOG member agency that total to \$294,410. These amounts have not been adjusted since FY 2009/2010. The only adjustments made to the overall dues levels have been the addition of the City of Beaumont and the Riverside County Superintendent of Schools, but the Morongo Band of Mission Indians also withdrew its membership from WRCOG. For comparison purposes, the total member dues that WRCOG has collected for years prior to 2009 are provided below. These dollars displayed below are raw dollars and do not account for inflation or any other dollar adjustment.

Present Situation

WRCOG was directed by its Administration & Finance Committee to work with its TAC to explore options. A working group consisting of TAC members has formed through a solicitation from the TAC Chair to ensure thorough exploration and valuable input from members. It is estimated that the working group will meet on a monthly basis through December 2023 to explore options, with recommendations brought forth to the TAC in early 2024. It is anticipated that the working group will explore whether member dues should, among possible options:

- 1. Remain static until action is taken each year in the budget process,
- 2. Contain an automatic escalator (fixed percentage, Consumer Price Index, etc.), or
- 3. Be modeled after the practice of some peer agencies where the Administrative cost is determined each year then allocated among the member agencies in accordance with the prescribed formula.

The goal of WRCOG is to ensure any proposed adjustments to member dues are approved early enough to be accounted for in each member agency's budget process for FY 2024/2025. TAC members who are interested in participating in the working group should reach out to Rod Butler (TAC Chair).

While no proposal to change member dues has been made, if a change is recommended, it will likely begin as early as FY 2024/2025.
