A. CalRecycle Activities Update

Rhiannon McCollough, CalRecycle's Local Assistance and Marketing Development Branch representative, provided resources that included educational tools for Senate Bill (SB) 1383 to help educate local decision makers and leaders. Many other tools and documents are available on CalRecycle's webpage.

ReCollect's disposal directory, Waste Wizard, is an online customizable collection calendar and waste sorting game that is available for any jurisdiction's website. Currently, the Cities of Banning, Hemet, Moreno Valley, and Wildomar utilize this on their respective websites. Online traffic is showing that residents are turning to more of the online services for more information, now more than ever. Staff encourages all jurisdictions to check it out.

D. Used Oil and Household Hazardous Waste Activities Update

Kyle Rodriguez, WRCOG Staff Analyst, reported that staff is still currently focusing on online education to help educate citizens about the proper disposal of used oil and household hazardous waste products. Another avenue WRCOG has pursued is digital billboards. Digital ads will be aired from now until February 2021 in the Cities of Eastvale, Perris, and Lake Elsinore, promoting the safe and proper disposal of used oil.

EcoHero has transitioned to virtual shows during the pandemic, but member jurisdictions can request in-person shows if wanted. To date, EcoHero has provided shows to a total of 11 schools, which has reached over 3,500 students.
